1 Briefly describe the organization's mission: Pine Castle, Inc. was established in 1952 to promote the general welfare of developmentally disabled individuals and to provide a center for training for persons with intellectual disabilities.

Services include adult education, life skills training, vocational training, facility-based employment, recreation and athletic opportunities, community inclusion and a senior program.

4b (Code:) (Expenses \$ 1,122,808. including grants of \$) (Revenue \$) Pine Castle's residential program serves 36 individuals in five group homes. The group homes offer 24-hour support staff for residents as well as skills training and community inclusion opportunities.

4c (Code:) (Expenses \$ 73,466. including grants of \$) (Revenue \$) Pine Castle's community employment program serves 20-30 individuals annually, by providing employment services to those who wish to work in the community. The program not only provides job training and placement, but also long-term follow-along services and support.


